

Web site disclaimer

- You must be 18 years or older to purchase long guns and 21 years or older to purchase hand guns. Check your local & state laws.
- Sanctuary Arms can only legally ship firearms to businesses which hold a valid Federal Firearms License (FFL Dealers).

You **must** complete the all the following steps to purchase a firearm from Sanctuary Arms online:

- Locate a FFL dealer in your area to accept the transfer of the firearm you want to order. This may be a local gun shop, pawn shop or gun range. The only requirement is that the business holds a current FFL and agrees to receive the firearm for you.
- Contact the local FFL Dealer and tell them you would like to transfer a firearm from Sanctuary Arms. **Most FFL dealers charge a fee for a firearm transfer.** The dealer's transfer fees are a separate agreement between you and the FFL dealer.
 - Sanctuary Arms DOES NOT arrange the transfer with your dealer.
 - To expedite your purchase make arrangements with your FFL dealer **BEFORE** you place your order with SANCTUARY ARMS.
- Place your SANCTUARY ARMS firearm purchase order online. You will receive an order confirmation e-mail with your order number.
 - Enter the FFL Dealer's name, address and telephone number in the comments box.
- Print and fill out our FFL Transfer Form: **.pdf** or **HTML**.
 - Include your order Number on the form.
 - Give the FFL Transfer form to your FFL Dealer to mail or fax with his license information.

- o Please keep all paperwork together in one envelope if possible.
- Write your name and order number on any correspondence you send us.
- Have your FFL dealer mail or fax a signed copy of their FFL and the Sanctuary Arm's FFL Transfer Form to:
- Once we have received a copy of your dealer's signed FFL and a completed Sanctuary Arms FFL Transfer Form we will ship the firearm to the FFL dealer.
 - o Handguns must ship air freight due to shipping regulations.
 - o Long guns may ship ground instead of air freight.
- We will send you an email with the tracking number when the firearm ships.
 - o We do not ship outside the United States.
 - o Firearms will not be shipped to any restricted locations.
- Once your FFL dealer receives your firearm, they will perform your background check. You will then need to complete all the necessary paperwork and pick up your gun.

To Purchase Ammunition Online:

Federal law requires that you must be at least 18 years old to purchase shotgun ammunition and 21 years or older to purchase handgun and rifle ammunition.

- You do not need an FFL to purchase ammunition online.
- All ammunition will be shipped UPS ground.
- We can ship ammunition to your door via UPS.
- When you are checking out, you must select UPS Ground if you are purchasing ammunition. Ammunition cannot be shipped air freight, due to shipping regulations.
- Ammunition and firearms must be purchased separately.
- For safety reasons, we do not accept returns on ammunition.
- Always make sure you use the correct ammunition for your specific firearm.
